- 4. I fully understand and agree to provide my services to CCP as a volunteer in a voluntary capacity without any employment-type benefits, including but not limited to employment insurance programs, worker's compensation accrual in any form, vacations or sick time.
- 5. I fully understand that CCP handles large numbers of animals on a daily basis. The temperament of these animals is unknown to CCP. I agree to hold CCP harmless for any injury(s) which I might sustain from handling animals during the course of my volunteer duties for CCP.
- 6. I fully understand and agree to assume all risks involved in any and all duties that I perform for CCP in my volunteer capacity. Such duties might include but are not limited to animal handling, custodial work, kennel assistance, and other foreseeable volunteer duties
- 7. I fully understand that CCP expects high standards of moral and ethical treatment of the animals under its care. I agree to adhere strictly to these standards in my voluntary capacity with CCP.

8. I fully understand and agree that either for failure to comply with any and all of these obligations outlined in this Volunteer Agreement or for any reason whatsoever, while performing my volunteer services to CCP in a voluntary capacity, CCP, at its sole discretion, may immediately terminate my services.

## **RELEASE**

This waiver and release of liability, indemnification and hold harmless agreement is between the volunteer and the Cenla Cat Project (CCP), P.O. Box 2597, Pineville, LA 71361, and its directors, officers, members, agents, assigns, legal representatives and successors (hereinafter referred to as CCP). As a foster that is 18 years old or older, I hereby understand and agree to the following: I agree to WAIVE and RELEASE the CCP from all liability, manner of actions, causes of action, debts, contracts, claims and demands for or by reason of any illness, death, damage, loss or injury to person and property, which has been or may be sustained as a direct or indirect consequence of the foster's fostering for the CCP and notwithstanding that such damage, death, illness, loss or injury may have been caused partly by the negligence of the CCP. I agree to INDEMNIFY and HOLD HARMLESS the CCP for any costs or liabilities which they may incur as a result of my volunteering for the CCP. I acknowledge and agree that I have carefully read this Agreement, that I fully understand the same, and that I freely and voluntarily execute the same. I understand that I may seek independent advice prior to signing this Agreement. I understand that this Agreement is binding on me, my spouse, my executors, administrators, personal representatives and assigns and that this Agreement has important legal consequences. The terms of this Agreement are contractual and not mere recitals. This Agreement will be construed in accordance with and governed by the laws of the State of Louisiana.

I hereby give the CCP the unrestricted right and permission to copyright and use, re-use, publish, and republish photographic pictures of me, or in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade or any other purpose whatsoever.
